ORDINANCE <u>2727</u>

ORDINANCE AMENDING SAN DIEGO UNIFIED PORT DISTRICT, PORT OF SAN DIEGO TARIFF NO. 1-G, RATES AND CHARGES, TO INCREASE CERTAIN RATES AND CHARGES AND UPDATE LANGUAGE

WHEREAS, the San Diego Unified Port District (District) is a public corporation created by the Legislature in 1962 pursuant to Harbors and Navigation Code Appendix I (Port Act); and

WHEREAS, Section 21 of the Port Act grants the Board of Port Commissioners (Board) authority to pass all necessary ordinances and resolutions for the regulation of the District; and

WHEREAS, District staff conducts an annual review of the District's Port of San Diego (Port) Tariff No. 1-G, which governs the rates, charges, rules and regulations applicable for all maritime-related commercial activity within the Port's jurisdiction; and

WHEREAS, the Board conducting a public hearing regarding the recommended rate increases and other amendments on June 11, 2013; and

WHEREAS, the rate increases would maintain a rate structure that is competitive with other California ports:

- a two percent (2%) increase in Wharfage for Lumber and Forest Products as well as Wharfage for Vehicles, referenced in Attachments F, H and I.
- a three percent (3%) increase in Dockage items, referenced in Attachments A and B.
- a three percent (3%) increase in Wharfage for all other commodities, referenced in Attachments C, D, E, F, G, H, I, J, K and L.
- a three percent (3%) increase in Wharf Demurrage, Wharf Storage and Space Occupancy items, referenced in Attachments M, N, O and P.
- a three percent (3%) increase in Miscellaneous items, referenced in Attachments Q, R, S, T, U, V and W.
- include a new Item No. 0748, Electrical Service for Shore Power.
- minor amendments of Tariff language and other minor language modifications, referenced in Attachments AA, BB, CC, DD, EE, FF, GG, HH and II

- **NOW, THEREFORE,** the Board of Port Commissioners of the San Diego Unified Port District does ordain as follows:
- Section 1. Tariff No. 1-G, posted on the website for the San Diego Unified Port District at www.portofsandiego.org (Organization No. 011576 Tariff No. 1-G), is hereby amended by adopting of the following:
- Section 2. The Wharfage for Lumber and Forest Products Item No. 0640 and Vehicles Item Nos. 0660(A), 0662(A), 0663(A), 0664(A)shall increase by two percent (2%).
- Section 3. The Dockage Item Nos. 0572(A) and 0575(A) shall increase by three percent (3%).
- Section 4. Wharfage Item Nos. 0600, 0605, 0610, 0614(I), 0615, 0617, 0618, 0619, 0620, 0625, 0627, 0629, 0630, 0631, 0635, 0637, 0641, 0645, 0647(C), 0650, 0665, 0666(A) 0670, 0671, 0673, 0674 All other commodities shall increase by three percent (3%).
- Section 5. Wharf Demurrage, Wharf Storage and Space Occupancy for Item Nos. 0705(A), 0720(A), 0725, 0735(A), 0736, 0737(A)shall increase by three percent (3%).
- Section 6. Miscellaneous Item Nos. 0738, 0740(C), 0745, 0750(A), 0758 shall increase by three percent (3%).
- Section 7. New Item No. 0748, Electric Service for Shore Power is added.
- Section 8. Minor amendments to Tariff language and other minor modifications are made.
- Section 9. This ordinance shall take effect after posting said revisions on the above-referenced website; provided, however, this ordinance shall not take effect prior to 31 days from its passage by the Board of Port Commissioners or July 11, 2013, whichever date is later.
