ORDINANCE 2732

ORDINANCE AMENDING SALARY ORDINANCE NO. 2688 ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE SAN DIEGO UNIFIED PORT DISTRICT"

The Board of Port Commissioners of the San Diego Unified Port District does ordain as follows:

Section 1. That Ordinance 2688 entitled "An Ordinance Establishing a Schedule of Compensation for Officers and Employees of the San Diego Unified Port District" is hereby amended by amending Attachment A thereto. Said amendment adds the following title and/or band/range number, and Fair Labor Standards Act (FLSA) status for these Classification Titles:
