ORDINANCE 2807

ORDINANCE RESCINDING SECTION 8.21 TO ARTICLE 8 OF THE SAN DIEGO UNIFIED PORT DISTRICT CODE – PARKING PILOT PROGRAM FOR TUNA HARBOR PUBLIC PARKING LOT, NORTH EMBARCADERO PUBLIC PARKING LOT AND RUOCCO PARK PUBLIC PARKING LOTS AND ADOPTING SECTION 8.21 TO ARTICLE 8 OF THE SAN DIEGO UNIFIED PORT DISTRICT CODE – PARKING RATES AT TIDELANDS PUBLIC PARKING LOTS AND GARAGES

WHEREAS, the San Diego Unified Port District (District) is a public corporation created by the Legislature in 1962 pursuant to Harbors and Navigation Code Appendix I (Port Act); and

WHEREAS, Section 21 of the Port Act authorizes the Board of Port Commissioners (BPC) to pass all necessary ordinances and resolutions for the regulation of the District; and

WHEREAS, Section 36 of the Port Act requires the BPC by ordinance to set parking rates for District owned public facilities; and

WHEREAS, as a result of the success of the pilot program in increasing parking turnover and revenue to the District staff recommends the BPC implement the hours and days of enforcement from the parking pilot program and rescind UPD Code, Article 8, Section 8.21 – Parking Pilot Program for Tuna Harbor Public Parking Lot, North Embarcadero Public Parking Lot and Ruocco Park Public Parking Lots, and adopt UPD Code Article 8, Section 8.21- Parking Rates at Tidelands Public Parking Lots and Garages which authorizes the Executive Director to establish market-based parking rates at all Tidelands public parking lots and garages up to the maximum BPC-approved parking rates; and

WHEREAS, a stakeholder outreach meeting was held on March 25, 2015. In addition to members of the public, stakeholders in attendance included several District tenants, parking operators and local residents. Stakeholder response to the proposed BPC actions was generally positive; and

WHEREAS, a public hearing regarding the long-term implementation of the hours and days of enforcement from the parking pilot program and the establishment of the new rate range for the Tidelands public parking meters was held on April 14, 2015.

NOW, THEREFORE, the Board of Port Commissioners of the San Diego Unified Port District does ordain as follows:

Section 1. That Section 8.21 to Article 8 of the San Diego Unified Port District Code – Parking Pilot Program for Tuna Harbor Public Parking Lot, North Embarcadero Public Parking Lot and Ruocco Park Public Parking Lots is hereby rescinded.

Section 2. That Section 8.21 to Article 8 of the San Diego Unified Port District Code is hereby adopted and reads as follows:

Section 8.21 – PARKING RATES AT TIDELANDS PUBLIC PARKING LOTS AND GARAGES

In order to efficiently utilize all District tidelands public parking lots and garages and maximize revenue to the District, the Executive Director is authorized to set market-based parking rates at all tidelands public parking lots and garages not to exceed the maximum rates for each user type as approved by ordinance of the Board of Port Commissioners (Board) as set forth herein.

Any changes to the maximum parking rates as established by the Executive Director shall be posted at each respective parking lot or garage for the duration of the time such parking rates are in effect.


