ORDINANCE <u>2811</u>

ORDINANCE REPEALING AND RESCINDING ORDINANCE 2807, RESCINDING SAN DIEGO UNIFIED PORT DISTRICT (UPD) CODE, ARTICLE 8, SECTION 8.21 – PARKING PILOT PROGRAM FOR TUNA HARBOR PUBLIC PARKING LOT, NORTH EMBARCADERO PUBLIC PARKING LOT AND RUOCCO PARK PUBLIC PARKING LOT

WHEREAS, the San Diego Unified Port District (District) is a public corporation created by the Legislature in 1962 pursuant to Harbors and Navigation Code Appendix I (Port Act); and

WHEREAS, Section 21 of the Port Act authorizes the Board of Port Commissioners BPC to pass all necessary ordinances and resolutions for the regulation of the District; and

WHEREAS, on April 14, 2015, the BPC rescinded San Diego Unified Port District (UPD) Code Section 8.21- Parking Pilot Program for Tuna Harbor Parking Lot, North Embarcadero Parking Lot and Ruocco Park Parking Lot; and

WHEREAS, on April 14, 2015 after a public hearing the BPC adopted a new Article 8, Section 8.21 to the UPD Code – Parking Rates at Tidelands Public Parking Lots and Garages – to read as follows:

Section 8.21 - PARKING RATES AT TIDELANDS PUBLIC PARKING LOTS AND GARAGES

In order to efficiently utilize all District tidelands public parking lots and garages and maximize revenue to the District, the Executive Director is authorized to set market-based parking rates at all tidelands public parking lots and garages not to exceed the maximum rates for each user type as approved by ordinance of the Board of Port Commissioners (Board) as set forth herein.

Any changes to the maximum parking rates as established by the Executive Director shall be posted at each respective parking lot or garage for the duration of the time such parking rates are in effect.

NOW, THEREFORE, the Board of Port Commissioners of the San Diego Unified Port District does ordain as follows:

Section 1. That Ordinance No. 2807, Section 8.21 to Article 8 of the San Diego Unified Port District Code – Parking Rates at Tidelands Public Parking Lots and Garages - is hereby repealed and rescinded.

Section 2. That former Section 8.21 to Article 8 of the San Diego Unified Port District Code – Parking Pilot Program for Tuna Harbor Public Parking Lot, North Embarcadero Public Parking Lot and Ruocco Park Public Parking Lot shall remain in full force and effect.

Section 3. This Ordinance, and said rates herein shall take effect on the 31st day from its passage by the Board of Port Commissioners and said rates shall be posted.
