**ORDINANCE 2863**

**ORDINANCE AMENDING SALARY ORDINANCE NO. 2851  
ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE  
OF COMPENSATION FOR OFFICERS AND EMPLOYEES  
OF THE SAN DIEGO UNIFIED PORT DISTRICT"**

The Board of Port Commissioners of the San Diego Unified Port District does ordain as follows:

Section 1. That Ordinance 2851 entitled "An Ordinance Establishing a Schedule of Compensation for Officers and Employees of the San Diego Unified Port District" is hereby amended by amending Exhibit A thereto. Said amendment adds the following title and/or band/range number, and Fair Labor Standards Act (FLSA) status for these classifications, as follows:




