## ORDINANCE 2906

ORDINANCE AMENDING SALARY ORDINANCE NO. 2903 ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE SAN DIEGO UNIFIED PORT DISTRICT"

Section 1.
