ORDINANCE 2919

**ORDINANCE ADOPTING THE FISCAL YEAR 2019
FINAL BUDGET**

WHEREAS, the San Diego Unified Port District (District) is a public corporation created by the Legislature in 1962 pursuant to Harbors and Navigation Code Appendix I (Port Act); and

WHEREAS, Section 46 of the Port Act states, "On or before the 15th day of June of each year, the district board shall estimate and determine the amount of money required by the district and shall adopt a preliminary budget..."; and

WHEREAS, Section 47 of the Port Act states, "On or before the 15th day of June of each year, the board shall publish a notice pursuant to Section 6061 of the Government Code in the district stating:

- (1) That the preliminary budget has been adopted and is available at a time and at a place within the district specified in the notice for inspection by interested taxpayers.
- (2) That on a specified date not less than one month after the publication of the notice and at a specified time and place, the district board will meet for the purposes of fixing the final budget, and that any taxpayer may appear and be heard regarding the increase, decrease or omission of any item in the budget, or for the inclusion of additional items."; and

WHEREAS, on May 8, 2018, the Board adopted the Fiscal Year (FY) 2019 Preliminary Budget and set June 12, 2018 as the date the Board will meet for the purposes of fixing the final budget, and a notice in compliance with Port Act Section 47 was published; and

WHEREAS, on June 12, 2018, the Board met for the purposes of fixing the final budget.

NOW, THEREFORE, the Board of Port Commissioners of the San Diego Unified Port District does ordain as follows:

Section 1. The final budget for FY 2019, as set forth in the document on file in the Office of the District Clerk, is hereby adopted as the Annual Budget for said Fiscal Year.


Section 2. There is hereby appropriated for expenditure out of the Revenue Fund of said District the following amounts:

Ordinary Annual Expenses	\$	172,223,100
Capital Improvement		33,321,000
Technology Capital Projects		4,270,000
Capital Major Maintenance		9,850,000
Equipment Outlay		4,938,500
Debt Service – Principal		4,698,000
Total Requirements	\$	<u>229,300,600</u>

All unexpended monies remaining in said Fund on June 30, 2019, together with monies transferred to said Fund or received in connection with said Fund during FY 2019 in excess of the requirements shown above, are hereby appropriated for the uses authorized in the San Diego Unified Port District Act.

Section 3. This ordinance is declared to take effect upon its publication, pursuant to the provisions of Section 21 of the San Diego Unified Port District Act.

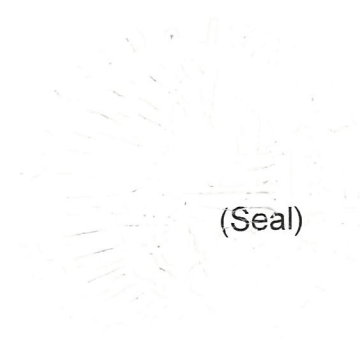
