RESOLUTION SELECTING AND AUTHORIZING A PURCHASE AGREEMENT WITH NEXUS IS INC. FOR CCTV INFRARED CAMERA ENHANCEMENTS "CISCO CATALYST FOR LOT D 3560c SWITCHES" AND LOT F "CISCO UNIFIED COMPUTING SYSTEM (UCS) BLADE CHASSIS EXPANSION PACK" FOR AN AMOUNT NOT TO \$62.758.96 FUNDED THE EXCEED BY DEPARTMENT OF HOMELAND SECURITY PORT **SECURITY GRANT PROGRAM FY2011**

WHEREAS, the San Diego Unified Port District (District) is a public corporation created by the legislature in 1962 pursuant to Harbors and Navigation Code Appendix 1, (Port Act); and

WHEREAS, the Board of Port Commissioners (BPC) adopted BPC Policy No. 110 Procedure for the Administration of Contracts, Agreements, the Purchasing of Supplies, Materials, and Equipment, and Grants; and

WHEREAS, in 2005 the District began installation of a Closed Circuit Television (CCTV) surveillance system funded by FY2002 of the Department of Homeland Security Port Security Grant Program; and

WHEREAS, the initial system focused on observing vulnerable assets at the marine terminals, waterside approaches, and recreational boat launch ramps; and

WHEREAS, the District has used a combination of funding sources since that time, including both Federal and California grant funds, to expand the CCTV surveillance system to also include the cruise ship terminals and several other buildings and structures of operational importance to the District; and

WHEREAS, the District desires to perform upgrades at a number of tidelands locations which already have existing day/night CCTV cameras to add Forward-Looking-Infrared (FLIR) CCTV Cameras to further enhance the CCTV system's capabilities; and

WHEREAS, the District also desires to replace a number of existing FLIR cameras that have reached end of life and require replacement; and

WHEREAS, the District applied for and received funding under the Department of Homeland Security Port Security Grant Program FY2011 for this enhancement; and

WHEREAS, on August 27, 2013, the District issued Request for Bid (RFB) 13-29 "CCTV Infrared Camera Enhancements"; and

WHEREAS, to increase the number of potential bidding firms the District divided the RFB into six separate lots based on manufacturer and type of hardware components being requested; and

WHEREAS, on October 16, 2013 fourteen bids were received and opened; and

WHEREAS, Nexus IS Inc. submitted the lowest bid of \$4,663.02 for Lot D "CISCO Catalyst 3560c Switches."

WHEREAS, Nexus IS Inc. submitted the lowest bid of \$58,095.94 for Lot F "Cisco Unified Computing System Blade Chassis Expansion Pack."

NOW, THEREFORE, BE IT RESOLVED that the Board of Port Commissioners of the San Diego Unified Port District, as follows:

That the Executive Director or his designated representative is hereby authorized on behalf of the San Diego Unified Port District to enter into a Purchase Agreement with Nexus IS Inc. for CCTV infrared camera enhancements for Lot D "CISCO Catalyst 3560c Switches" and Lot F "Cisco Unified Computing System Blade Chassis Expansion Pack" for an amount not to exceed \$62,758.96 funded by the Department of Homeland Security Port Security Grant Program FY 2011.
