RESOLUTION SELECTING AND AUTHORIZING WITH **AGREEMENTS** GEOSYNTEC CONSULTANTS, INC., AMEC ENVIRONMENT AND INC., INFRASTRUCTURE, AND WESTON INC.. FOR **AS-NEEDED** SOLUTIONS. **ENVIRONMENTAL ANALYTICAL SERVICES SUCH** SEDIMENT AND WATER COLLECTION, LABORATORY AND TECHNICAL ANALYSIS, AND TECHNICAL REPORTING, IN AN AGGREGATE AMOUNT NOT TO \$675,000 FOR A PERIOD OF TWO YEARS

WHEREAS, the San Diego Unified Port District (District) is a public corporation created by the Legislature in 1962 pursuant to Harbors and Navigation Code Appendix I (Port Act); and

WHEREAS, the Board of Port Commissioners (BPC) adopted BPC Policy No. 110 establishing a procedure for the administration of contracts and the purchasing of supplies, materials, and equipment, and establishing a policy governing the processing and administration of contracts; and

WHEREAS, the District's Environmental & Land Use Management (ELUM) department reviews District and tenant sponsored projects for compliance with the California Environmental Quality Act (CEQA), the National Environmental Policy Act (NEPA), the California Coastal Act (Coastal Act), the Port Master Plan (PMP), and related laws and regulations in accordance with protecting the tidelands trust; and

WHEREAS, the District conducts environmental studies as required by permits and regulations, and to further the success of District environmental stewardship, which often require highly technical analysis; and

WHEREAS, pursuant to BPC Policy No. 110, District staff issued a Request for Proposals (RFP) in February 2014 seeking up to three qualified firms to continue as-needed laboratory, bioassay, and survey and sample collection services; and

WHEREAS, five of the seven firms that submitted proposals were selected as finalists and interviewed by staff; and

WHEREAS, based on the interviews, the written proposals and a decision analysis process using the criteria stated in the RFP, staff recommends that the

BPC select Geosyntec Consultants Inc. (Geosyntec), AMEC Environment and Infrastructure Inc. (AMEC) and Weston Solutions Inc. (Weston) for the as-needed Environmental Analytical Services agreements; and

WHEREAS, upon BPC approval, Agreements #70-2014, #69-2014, and #71-2014 (attached to the corresponding agenda sheet as Attachments A, B, C, respectively) between the District and the three firms would be executed for a period of two years and for an aggregate amount not to exceed \$675,000.

NOW, THEREFORE, BE IT RESOLVED by the Board of Port Commissioners of the San Diego Unified Port District, as follows:

That the Executive Director or his designated representative is hereby authorized to select and enter into agreements on behalf of the San Diego Unified Port District with Geosyntec Consultants, Inc., Amec Environment and Infrastructure, Inc., and Weston Solutions, Inc., for As-Needed Environmental Analytical Services such as sediment and water sample collection, laboratory and technical analysis, and technical reporting, in an aggregate amount not to exceed \$675,000 for a period of two years.
