## **RESOLUTION 2014-174**

RESOLUTION ESTABLISHING RENT FOR CALIFORNIA YACHT MARINA - CHULA VISTA, LLC FOR THE PERIOD FROM JULY 1, 2014 THROUGH JUNE 30, 2019

- WHEREAS, the San Diego Unified Port District (District) is a public corporation created by the legislature in 1962 pursuant to Harbors and Navigation Code Appendix 1, (Port Act); and
- WHEREAS, Section 87(b) of the Port Act grants authority to the District to lease the tidelands or submerged lands, or parts thereof, for limited periods, not exceeding 66 years, for purposes consistent with the trusts upon which those lands are held, by the State of California; and
- WHEREAS, California Yacht Marina (CYM) operates a 352-slip marina located at 640 Marina Parkway in the City of Chula Vista; and
- **WHEREAS**, CYM has a 40 year lease with the District, which expires June 30, 2029; and
  - WHEREAS, the lease provides for periodic rent adjustments; and
- **WHEREAS**, the next rent adjustment is for the 5-year period commencing July 1, 2014 and ending June 30, 2019; and
- **WHEREAS**, the minimum annual rent (MAR) is currently \$222,000 and the lease provides that the MAR shall be set at no less than 75% of the average percentage rental paid during the last three accounting years of the previous rental period; and
- **WHEREAS**, during the three-year period commencing July 1, 2011 and ending June 30, 2014, CYM paid the District an average of approximately \$227,000 per year in rent under the subject lease; and
- **WHEREAS**, the current MAR of \$222,000 is well above the 75% required under the lease; and
- **WHEREAS**, the percentage rental rates currently in effect are consistent with those adopted by the Board of Port Commissioners in December 2004 and therefore staff proposes that they remain the same.

NOW, THEREFORE, BE IT RESOLVED that the Board of Port Commissioners of the San Diego Unified Port District, as follows:

That the Executive Director or his designated representative is hereby authorized on behalf of the San Diego Unified Port District to establish the current minimum annual rent of \$222,000 be maintained and current percentage rental rates stay in effect for California Yacht Marina - Chula Vista, LLC for the period July 1, 2014 through June 30, 2019.
