**RESOLUTION AUTHORIZING AN AGREEMENT
WITH SAN DIEGO COUNTY OFFICE OF
EDUCATION TO ASSIST REGIONAL
OCCUPATIONAL PROGRAM STUDENTS IN
DEVELOPING OCCUPATIONAL COMPETENCIES
THROUGH AN UNPAID ON-THE-JOB TRAINING
PILOT PROGRAM AT THE SAN DIEGO UNIFIED
PORT DISTRICT AND GRANT INDEMNITY TO SAN
DIEGO COUNTY OFFICE OF EDUCATION FOR
THE PERIOD OF SEPTEMBER THROUGH
DECEMBER 2014**

WHEREAS, the San Diego Unified Port District (District) is a public corporation created by the Legislature in 1062 pursuant to Harbors and Navigation Code Appendix I, (Port Act); and

WHEREAS, the San Diego County Office of Education offers employment opportunities for youth in San Diego through a Regional Occupational Program (ROP); and

WHEREAS, ROP offers vocational and technical skills training, career preparation and job search programs; and

WHEREAS, the District has an opportunity to increase awareness of public administration and assist the ROP students enrolled at Morse High School by providing unpaid on-the-job training experience at the District during the school semester of September through December 2014; and


WHEREAS, students would receive class credit and gain on-the-job training experience while the District would be growing interest in public administration and employees will gain mentoring and training experience; and

WHEREAS, the District's participation requires an agreement with San Diego County Office of Education which includes mutual indemnity language where both parties agree to defend and indemnify the other for their negligence.

NOW, THEREFORE, BE IT RESOLVED by the Board of Port Commissioners of the San Diego Unified Port District, as follows:

That the Executive Director or his designated representative is hereby authorized on behalf of the San Diego Unified Port District to enter into the agreement with San Diego County Office of Education to assist Regional Occupational Program students in developing occupational competencies through an unpaid on-the-job training pilot program at the San Diego Unified Port District and grant indemnity to San Diego County Office of Education for the period of September through December 2014.




