## **RESOLUTION 2017-071**

RESOLUTION APPROVING A BUDGET TRANSFER OF \$608,600, PURSUANT TO BPC POLICY NO. 90, TRANSFER BETWEEN OR WITHIN APPROPRIATED ITEMS IN BUDGET, INCREASING THE EQUIPMENT TRANSFERRING OUTLAY APPROPRIATION BY \$278,600 FROM SAVINGS IN PERSONNEL EXPENSE **FROM** THE **TECHNOLOGY** AND \$330,000 STRATEGIC PLAN (TSP) CAPITAL **PURCHASE VARIOUS APPROPRIATIONS** TO **EQUIPMENT NEEDS** 

WHEREAS, the San Diego Unified Port District (District) is a public corporation created by the Legislature in 1962 pursuant to Harbors and Navigation Code Appendix I (Port Act); and

**WHEREAS**, pursuant to BPC Policy No. 90, a budget transfer of an amount between appropriated items requires Board approval; and

WHEREAS, Staff is recommending the FY 2017 Equipment Outlay Appropriation be increased by \$608,600 to fund the purchase of equipment including a shore power extension cord, Closed Circuit Television (CCTV) video mass storage recorders, covered structures, boat engines, physical access control system upgrade, network analysis tablet, paper cutter, and cubicle workstations; and

**WHEREAS**, the recommended increase of \$608,600 to Equipment Outlay Appropriation will be funded by transferring \$278,600 from Personnel Expense and \$330,000 from TSP Capital Appropriations; and

**WHEREAS**, approval of this resolution transferring funds to the Equipment Outlay Appropriation in the amount of \$608,600 will increase the Equipment Outlay budget from \$3,884,000 to \$4,492,600.

**NOW**, **THEREFORE**, **BE IT RESOLVED** that the Board of Port Commissioners of the San Diego Unified Port District hereby authorizes a budget transfer of \$608,600, pursuant to BPC Policy No. 90, Transfer Between or Within Appropriated Items in Budget, increasing the Equipment Outlay Appropriation by \$608,600 by transferring \$278,600 from Personnel Expense and \$330,000 from the TSP Capital Appropriations for the purchase of various equipment needs.
