RESOLUTION APPROVING CALENDAR YEAR 2018 WORK PLAN FOR THE ACCESSIBILITY ADVISORY COMMITTEE PURSUANT TO BOARD OF PORT COMMISSIONERS POLICY NO. 18- BOARD ADVISORY COMMITTEES

WHEREAS, the San Diego Unified Port District (District or Port) is a public corporation created by the legislature in 1962 pursuant to Harbors and Navigation Code Appendix 1 (Port Act); and

WHEREAS, Board of Port Commissioners (BPC or Board) Policy No. 18 provides authority for establishment of Board Advisory Committees; and

WHEREAS, the Accessibility Advisory Committee (AAC) is an eight-member committee representing a broad spectrum of disabilities including mental and physical disabilities as defined by the Americans with Disabilities Act (ADA); and

WHEREAS, its overall mission is to educate, advise and assist the Board in ensuring that all services, programs and facilities on Port Tidelands are fully usable and accessible to all; and

WHEREAS, the ACC's vision is Universal Design, which is the design of products and environments to be usable by all to the greatest extent possible, without the need for adaptation or specialized design; and

WHEREAS, BPC Policy No. 18 Guidelines Section 9 requires that at the beginning of each calendar year, each Committee prepare a general work plan with goals for the coming year and submit it to the BPC; and

WHEREAS, in accordance with BPC Policy No. 18, the AAC reviewed and approved its work plan for 2018 at its meeting on March 21, 2018; and

WHEREAS, in support of the District's Strategic Goals, the AAC's work plan focuses on three general categories, including outreach and education, ADA enhancement projects, and Universal Design efforts, and is fully set forth in Attachment A to the agenda sheet; and

WHEREAS, focusing on these categories will continue fostering positive connection to the community and accessibility for all on Tidelands; and

WHEREAS, AAC members discussed the work plan and recommended the plan be submitted to the BPC for approval.

NOW, THEREFORE, BE IT RESOLVED by the Board of Port Commissioners of the San Diego Unified Port District, as follows:

Adopt a resolution approving calendar year 2018 work plan for the Accessibility Advisory Committee pursuant to BPC Policy No. 18-Board Advisory Committees.


