**RESOLUTION APPROVING PROCLAMATION IN
RECOGNITION OF JULY 2020 AS PARK AND
RECREATION MONTH, ENCOURAGING PEOPLE
TO GET ACTIVE, ENJOY THE OUTDOORS, AND
STAY HEALTHY AND SAFE DURING THE
PANDEMIC**

WHEREAS, the San Diego Unified Port District (District) is a public corporation created by the Legislature in 1962 pursuant to Harbors and Navigation Code Appendix I (Port Act); and

WHEREAS, section 35 of the Port Act allows the Board of Port Commissioners (BPC) to do all acts necessary and convenient for the exercise of its powers; and

WHEREAS, section 21 of the Port Act allows the BPC to pass all necessary resolutions for the regulation of the District; and

WHEREAS, each year in July, parks and recreation professionals join in a nationwide effort to recognize the importance and value of public parks and recreational opportunities for overall quality of life through educational outreach and programming efforts; and

WHEREAS, this year, due to the unprecedented impact of the worldwide COVID-19 pandemic, activation of the waterfront with traditional special events and public gatherings has been temporarily suspended, and innovative new ways of doing things have emerged from the recent creation of “virtual” events-held entirely off site-with a new focus on encouraging residents to get active, safely enjoy the outdoors, and stay healthy during the pandemic; and

WHEREAS, Park and Recreation Month was launched by the National Recreation and Park Association (NRPA) in 1985; and

WHEREAS, since that time, the nation has celebrated Park and Recreation Month in July to promote the importance of parks and recreation in health and wellness, conservation, and social equity; and to recognize the thousands of parks and recreation employees that maintain our nation’s local, state, and community parks; and

WHEREAS, parks and recreation services are vital for our communities, from protecting open space and natural resources to helping fight obesity and providing activities and resources for all walks of life, as Park and Recreation Month encourages everyone to reflect on the exponential value parks and recreation bring to communities; and

WHEREAS, the District manages public access to 22 beautiful parks, as well as public boat launches, fishing piers, and a collection of distinct artworks found in tidelands parks; and

WHEREAS, Park and Recreation Month raises public awareness about the role of open space and recreation in communities and people’s lives; it encourages individuals and organizations to participate in outdoor activities and allows governments and businesses to show their commitment to planning and maintaining green spaces in urban settings; and

WHEREAS, the proposed proclamation would be an acknowledgement of the District’s long-standing commitment to stewardship and management of the District’s parks.

NOW, THEREFORE, BE IT RESOLVED that the Board of Port Commissioners of the San Diego Unified Port District, does hereby proclaim and recognize July 2020 as Park and Recreation Month.
