- **WHEREAS**, presently serving their first term on the PAB ending on September 1, 2020, and being recommended for a second term, are the following members: Stephen Cascioppo, Anthony Chartrand and Traci Becerra; and
- **WHEREAS**, Stephen Cascioppo, Anthony Chartrand and Traci Becerra are first term PAB members in good standing and desire to serve a second term of three years duration; and
- **WHEREAS**, District staff is recommending that the Board Stephen Cascioppo, Anthony Chartrand and Traci Becerra to the PAB.
- **NOW, THEREFORE, BE IT RESOLVED** that the Board of Port Commissioners of the San Diego Unified Port District, hereby reappoints Stephen Cascioppo, Anthony Chartrand and Traci Becerra to the San Diego Unified Port District, Personnel Advisory Board for a second term of three years' duration commencing September 10, 2020.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, San Diego Unified Port District (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
