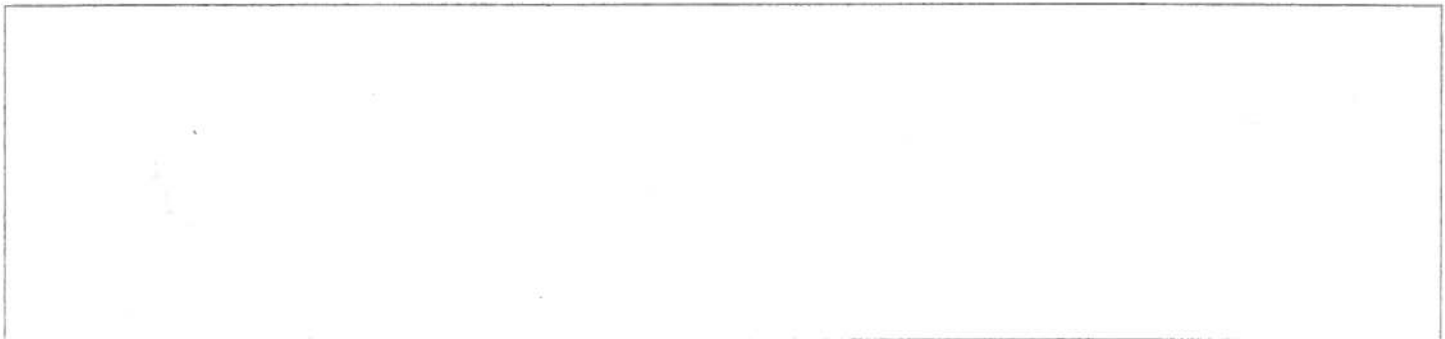

Description of Nature, Purpose, and Beneficiaries of Project: *The proposed project is a Tideland Use and Occupancy Permit (TUOP) to Maxum Petroleum (Tenant) for their continued use of approximately 55,488 square feet of tideland area located in the city of San Diego, California. The area proposed for use under this TUOP is currently and proposed to be used for the non-exclusive purpose by Tenant of fueling operations to commercial and private vessels located on or adjacent to the premises and for no other purpose whatsoever by Tenant without the prior written consent of the Executive Director of District in each instance. The Tenant would be responsible for compliance with all laws and regulations associated with the activities on or in connection with the above-described premises, and in all uses thereof, including those regulating stormwater and hazardous materials. No new development, construction, uses, or increase in the size of the Tenant's TUOP area is proposed or authorized as part of this TUOP.*

It is anticipated that the TUOP would commence on January 1, 2018 and terminate on December 31, 2021, for a total term of four (4) years. The TUOP may be terminated by the Executive Director of District or her duly authorized representative, or Tenant, as a matter of right and without cause at any time upon the giving of thirty (30) days' notice in writing to the other party of such termination.

Reason Why Project is Exempt: *the project is determined to be Categorically Exempt pursuant to California Environmental Quality Act (CEQA) Guidelines Section 15301 (Existing Facilities) and Section 3.a. (4) of the District's Guidelines for Compliance with CEQA because the project is a TUOP for the purpose of fueling operations to commercial and private vessels that would involve no expansion of use beyond that previously existing. Section 3.a. (4) of the District's CEQA Guidelines is as follows:*

Existing Facilities (SG § 15301) (Class 1): *Includes operation, repair, maintenance, or minor alteration of existing public and private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that previously existing, including but not limited to:*
 - (4) *New and renewed short-term tenancy agreements which do not result in change in the existing use. This exemption does not apply to any new development associated with the activities of the tenant. This exemption is also inapplicable if the cumulative impact of continuing the existing use or conditions in the same place, over time, is significant.*
