Project Title: Repair to Concrete Breakwater by Marine Group Boat Works, LLC in Chula Vista

Project Location - Specific: 997 G Street, Chula Vista, CA 91910

Project location – City: <u>Chula Vista</u> Project Location – County: San Diego

Description of Nature, Purpose, and Beneficiaries of Project: The proposed project would involve repairs to a damaged concrete breakwater by Marine Group Boat Works, LLC (Applicant) in the city of Chula Vista, California. A recent inspection showed that the structural integrity of the concrete breakwater was compromised after a tugboat collided with it in late 2022. The concrete breakwater surrounds and protects the Marine Group Boat Works marina basin and shoreline structures from ocean waves, and it consists of vertical and batter piles, and precast and cast-in-place reinforced components totaling approximately 918 feet in length. The impact of the accident resulted in four (4) broken concrete pilings, the shift of the existing plumb piles out of alignment, and three (3) broken precast wall panels. The proposed project would remove and replace in-kind components of the breakwater between bents 8-11 to ensure it is structurally sound.

Work to specifically complete the proposed project would involve the following:

- Remove and replace total of four (4) broken piling, consisting of two (2) 16-inch square battered piling and two (2) 16-inch octagonal plumb piling
- Remove and replace three (3) broken precast wall panels
- Remove and replace two (2) precast
- Install new cast-in-place concrete cap

The new piles would be installed by water jetting and driving the piles into position. Precast pile jackets would be cast off-site and installed over the two (2) new plumb pilings. After the pile jackets are installed, new precast wall panels would be set into the pile jackets pockets and grouted into position. To tie the breakwater wall together, a new cast-in-place concrete cap would be constructed on the top of the wall panels and piles from bents 8-11. Construction of the proposed project is anticipated to occur in approximately Fall 2023 and would take approximately 60 days to complete.

Reason Why Project is Exempt: The proposed project is determined to be Categorically Exempt pursuant to the CEQA Guidelines and the Sections of the District's Guidelines for Compliance with CEQA as identified above. These are appropriate for the proposed project because it would involve repairs to an existing concrete breakwater that would involve no expansion of use beyond that previously existing, would consist of the

replacement of an existing structure, and would result in no permanent effects on the environment. Sections 3.a.(1)(9), 3.b.(1), and 3.d.(1) of the District's CEQA Guidelines are as follows:

- 3.a. Existing Facilities (SG § 15301) (Class 1): Includes operation, repair, maintenance, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that previously existing, including but not limited to:
  - (1) Repair, maintenance or minor alteration of existing mooring facilities, floats, piers, piles, wharves, bulkhead, revetment, buoys, or similar structures; marine terminal facilities; airport facilities; and commercial industrial, or recreational facilities.
  - (9) Restoration or rehabilitation of deteriorated or damaged structures, facilities or mechanical equipment to meet current standards of public health and safety or permit requirements, unless it is determined that the damage was substantial and resulted from an environmental hazard such as earthquake, landslide, or flood.

- 3.b. Replacement or Reconstruction (SG § 15302) (Class 2): Includes replacement or reconstruction of existing structures and facilities where the new structure will be located on the same site and will have substantially the same purpose and capacity as the structure being replaced. This exemption includes, but is not limited to:
  - (1) Replacement or reconstruction of mooring facilities, piles, floats, piers, wharves, marine ways, bulkhead, revetment, buoys, or similar structures where the new structure will be on essentially the same site as the structure replaced and will have substantially the same size, purpose and capacity as the structure replaced.


