Description of Nature, Purpose, and Beneficiaries of Project: The proposed project involves an agreement between San Diego Unified Port District (District) and Allied Waste Systems, Inc. dba Republic to provide solid waste and recycling collection, disposal, and management services at various District facilities and as needed locations. Services include the removal of waste generated by routine District operations such as construction activities, boat demolition, landscaping maintenance and the scheduled collection and recycling of paper, aluminum, plastics, glass, etc. at District facilities. Services would also include the provision of dumpster and recycling containers to various District locations.

The agreement is anticipated to commence August 1, 2024, and terminate on June 30, 2029, in an amount not to exceed \$1,800,000. Furthermore, Allied Waste Systems, Inc. would be responsible for complying with all applicable federal, state, and local laws regarding solid waste and recycling services.
