Project Title: FY 2018 Capital Major Maintenance Program- Razor Wire Perimeter Fencing at TAMT
Project Location – Specific: 1800 Crosby Rd, San Diego, CA 92101

Description of Nature, Purpose, and Beneficiaries of Project: The proposed project involves the installation of razor wire on existing perimeter fencing at Tenth Avenue Marine Terminal located in the city of San Diego, California. No new development is proposed as part of the project and the installation would not increase the size or capacity of the existing structure. Work to specifically complete the proposed project would include the following:

- Installation of approximately 5,600 linear feet of razor wire onto existing fencing; and
- Maintenance repairs of existing fencing and outriggers.

Construction of the proposed project is anticipated to commence in May 2018 and take approximately one month to complete. Due to its nature and limited scope, construction of the proposed project would generate a minor amount of vehicle and truck trips and would require limited use of construction equipment. Vehicle trips would be associated with deliveries, transport of construction workers, and hauling of debris. Therefore, no impacts are anticipated. Furthermore, the applicant would be responsible for complying with all applicable federal, state, and local laws regulating construction demolition debris, noise, and stormwater.

Reason Why Project is Exempt: The proposed project is determined to be Categorically Exempt pursuant to California Environmental Quality Act (CEQA) Guidelines Section 15301 (Existing Facilities) and Section 3.a. (1) of the District's Guidelines for Compliance with CEQA because the project proposes the installation of razor wire on existing perimeter fencing that would involve no expansion of use beyond that previously existing.
