

## SAN DIEGO UNIFIED PORT DISTRICT NOTICE OF COMPLETION & PUBLIC HEARING

## National City Balanced Plan PROPOSED PORT MASTER PLAN AMENDMENT

A draft Port Master Plan Amendment (PMPA) has been prepared for San Diego Unified Port District (Port District) lands in Planning District 5, National City Bayfront, of the Port Master Plan. The PMPA area is in National City, generally north of Sweetwater Channel, south of Bay Marina Drive, east of San Diego Bay and the National City Marine Terminal, and west of Paradise Marsh (National Wildlife Refuge) and Interstate 5.

The draft PMPA proposes changes to land and water use designations to reflect the National City Marina District Balanced Land Use Plan (Balanced Plan), with a variety of uses such as: park, habitat buffers, overnight accommodations (RV park, modular cabins, hotels), dry boat storage, connector and storage rail tracks, commercial recreation, and maritime operations. Proposed in-water uses include: new moorings and floating docks, and the addition of a pier platform to place/remove dry boat storage boats in/from the water. The draft PMPA would also: add a new subarea to Planning District 5; incorporate two Port District-owned uplands properties into the PMP; convert Tidelands Avenue between Bay Marina Drive and 32<sup>nd</sup> Street, and 28<sup>th</sup> Street between Quay Avenue and Tidelands Avenue from their current land use designation of "street" to "marine related industrial;" revise the Circulation/Navigation Element to identify a new alignment of the Bayshore Bikeway; and update text, tables and the Planning District 5 project list to reflect the above changes.

The PMPA will be considered for approval, with or without modification, by the Board of Port Commissioners (BPC) following a public hearing on **Tuesday, October 11, 2022**. Additional hearing dates, if required, will be announced at that BPC meeting. Pursuant to Public Resources Code Section 30712, the public hearing may occur within 90 days of publication of this notice.

The BPC meeting will begin at 1:00 p.m. in the Board Room of the Port District Administration Building (3165 Pacific Highway, San Diego, CA 92101). The public is welcome to attend in person or watch via livestream on the Granicus Agenda & Meeting Link and/or the Microsoft Teams Meeting Link on the Port District's website at <a href="https://www.portofsandiego.org/about-port-san-diego/board-meetings">https://www.portofsandiego.org/about-port-san-diego/board-meetings</a>.
