- 3. Enforcement Required is the number of corrective actions issued to a facility for individual BMP implementation that is not identified as a "violation" and did not trigger "Escalated Enforcement." Four of the 11 "Enforcement Required" for commercial facilities on the JRMP Annual Report form were related documentation requirements only.
- 4. Escalated Enforcement is a response to a violation of a BMP identified in the Port's JRMP Chapter 6 and 7 that addresses the Port's WQIP priority pollutants (trash, bacteria, and metals). Escalated Enforcement results in an immediate administrative citation that can be with or without fines (escalated work order for municipal facilities).
- 5. All non-compliance issues requiring corrective enforcement actions were resolved and closed.

 primary and secondary types of debris observed in both BMP and MS4 structures were leaves and trash
 respectively. Several MS4s and BMPs were cleaned in the 2022-2023 monitoring year due to scheduling
 conflicts.



Funding Sources: The Port's implementation of its Municipal Permit requirements is budgeted and approved annually by the Board of Port Commissioners. The Port is accounted for as an enterprise fund and generates revenue from four major revenue sources; 1) charges received from Marine Operations, 2) charges received by Real Estate Operations, 3) the Port's Cost Recovery Program, and 4) reimbursement for services charged to the San Diego Regional Airport Authority. Legal restrictions related to the use of these funds are generally centered on the standard public contracting and fiscal reporting requirements. See the Port JRMP Chapter 10 for additional description of each funding source.
