1. One low priority inlet and one low priority manhole were inaccessible due to safety restrictions and were, therefore, not inspected.

 A total of 27 low priority outfalls were inaccessible because they are located underneath a pier or overhanging structure. At least one feature on 26 of the 27 outfall conveyance lines was inspected. The remaining outfall not inspected did not have accessible upstream features.

3. A total of 21 MS4 structures were located within construction areas and inspected under the Construction Management Program.

4. Prioritization of each MS4 structure is determined by the overall threat to water quality ranking given to the associated facility. These rankings are evaluated and modified on an annual basis to address empirical data gathered from inspections, such as water quality threat verification, BMP implementation, and compliance history.

5. Of the total 348 high priority MS4 structures, 21 were inspected at an increased frequency based on an accumulation analysis and prioritization process performed following the 2021-2022 monitoring year.

6. BMPs and MS4s required cleaning if inspections indicated >33% accumulation of debris in the structure. The primary and secondary types of debris observed in both BMP and MS4 structures were sediment and debris, respectively.



Funding Sources: The Port's implementation of its Municipal Permit requirements is budgeted and approved annually by the Board of Port Commissioners. The Port is accounted for as an enterprise fund and generates revenue from four major revenue sources; 1) charges received from Marine Operations, 2) charges received by Real Estate Operations, 3) the Port's Cost Recovery Program, 4) reimbursement for services charged to the San Diego Regional Airport Authority, and 5) Fiscal Recovery Funds received for infrastructure from the State of California's General Fund and managed by the State Lands Commission to help mitigate the negative economic impacts of the COVID-19 pandemic. Legal restrictions related to the use of these funds are generally centered on the standard public contracting and fiscal reporting requirements. See the Port JRMP Chapter 10 for additional description of each funding source.
