

## PEDICAB CODE OF CONDUCT

I [ADD NAME, COMPANY] agree to abide by this Pedicab Code of Conduct while operating on District Tidelands. I [ADD NAME, COMPANY] further agree that all of my employees and anyone else who operates a Pedicab under my Pedicab Operating Agreement will abide by this Pedicab Code of Conduct while operating on District Tidelands. I understand that my Pedicab Operating Agreement may be suspended or terminated for failure to comply with the following Pedicab Code of Conduct and/or any violation of applicable laws, rules, and/or regulations:

1. No person shall operate a Pedicab for hire within the Port District boundaries without a valid Pedicab Operating Agreement issued by the District.
2. No person shall operate a Pedicab without displaying the valid Pedicab Placards/Decal issued by the District. Placards/Decals cannot be covered or removed from the location they are affixed on each Pedicab by District representatives.
3. No person shall operate a Pedicab within those portions of the District that share jurisdictional boundaries with the City of San Diego, without first having obtained a Pedicab Operating Permit from the City of San Diego.
4. Must display City of San Diego Operator's Permit, company name and company phone number clearly displayed on the outside and inside of the Pedicab at all times.
5. Motorized Pedicabs shall not ride, park, or otherwise operate on any sidewalk, promenade, multi-use pathway, nature trail, plaza, public parking garage, pier or park, and shall operate the same as motor vehicles in driveways and on streets.
6. Pedal-Only Pedicabs shall not ride, stage, or otherwise operate on any sidewalk, promenade, multi-use pathway, nature trail, plaza, public parking garage, pier, or park, unless specifically designated as a "Pedal-Only" allowed route as defined in the Operating Agreement Maps, Exhibit B, attached herein. Pedal-Only Pedicabs may operate on roadways, streets, and driveways where Motorized Pedicabs are allowed to operate.
7. No person under the age of eighteen (18) years old shall operate a Pedicab.
8. Must drive safely and not at speeds that will endanger pedestrians.
9. Must not operate a Pedicab at a speed that is unsafe for roadway conditions.
10. Must always ensure the safety of Pedicab passengers and take all necessary measures to avoid collisions or incidents.
11. Must operate in such a manner as to not impede the free flow of pedestrians.
12. No Pedicab can drive onto, stage, or operate on any pier on District tidelands, including but not limited to, B Street Pier, Broadway Pier, Navy Pier, or Imperial Beach Pier.
13. Must obey all traffic signals, signs and posted speed limits.
14. Must come to a full stop at all stop signs.
15. Must come to a complete stop and remain stopped at all red traffic signals.
16. Must not make a U-turn in a business district, except at an intersection that does not prohibit U-turns.
17. Must drive Pedicab as close as practical to the right or left edge of the road on any one-way or two-way roadways and streets.
18. Must always drive Pedicab in the same direction as vehicles are required to be driven on the roadways, streets and in parking lots and driveways.
19. Must not drive Pedicab the wrong way on a one-way street or driveway.

20. Must not pass a motor vehicle or Pedicab left of a double yellow line.
21. Must make all right turns from the far-right hand edge of the road.
22. Must make all left turns from the far-left lane open to vehicles traveling in Pedicab's direction.
23. Must not drive Pedicab over or in a painted center island designated by double-parallel yellow lines.
24. Must keep to the right except to pass.
25. Must always give pedestrians the right of way.
26. Must use hand or mechanical signals when turning or changing lanes.
27. Must not block crosswalks, promenades, and ingress or egress to District leaseholds.
28. Must not park in a manner that impedes traffic, buses, shuttles, other vehicles, or pedestrians.
29. Must never grab onto or attach a Pedicab to any moving vehicle.
30. Must not drive Pedicab to the right or left in an unsafe manner or drive while swerving.
31. Must not operate any amplified sound devices and must not amplify any sound or music which can be audible outside of the pedicab while operating on District tidelands.
32. Must immediately report all accidents and injury collisions involving a Pedicab on District tidelands to **Harbor Police at 619-686-6272**.
33. Must provide the Pedicab company's insurance information upon demand by any party involved in a collision or incident with a Pedicab and a vehicle, pedestrian, property or animal.
34. Must not permit anyone other than the Permitted Pedicab Operator to drive the Pedicab.
35. Pedicabs must only be operated by one person, and the total number of passengers shall be limited by the total number of seatbelts provided in the Pedicab seating area.
36. Must ensure that all passengers wear a seatbelt at all times while inside the Pedicab.
37. Must not overload a Pedicab. All passengers must sit on the seat of the Pedicab, and no passengers are allowed on the lap of another passenger.
38. Must not operate a Pedicab while carrying any package, bag, or bundle that prevents the use of at least one hand to steer the Pedicab.
39. Must not leave the Pedicab unattended in the Pedicab Parking Zones.
40. Must not sit in the passenger seat while waiting for passengers.
41. Must only use designated Pedicab Parking Zones and do not park outside of Pedicab Parking Zones.
42. Must not smoke or use a mobile phone while operating a pedicab.
43. Must be courteous and not aggressive when soliciting for passengers.
44. Must post a per person fare schedule in accordance with size requirements within Pedicab Operating Agreement that are clearly visible to all passengers outside and inside of the Pedicab.
45. Must verbally agree to a total per person fare prior to commencing a ride with passengers.
46. Must not demand a fare greater than the fare posted on the fare schedule.
47. Must not operate a Pedicab under the influence of alcohol or any controlled substance.
48. Must ensure all luggage or personal items are properly secured within the Pedicab.
49. Complete Pedicab safety checks each time you take out a Pedicab, including seatbelts, lights, and brakes, etc.
50. Must not operate a Pedicab within the perimeter of a special event area, except at a designated drop off or pick up zone as may be designated by the District or City.

51. Must not operate within any restricted/posted construction zone and follow all posted construction zone signs and detours.
52. Must not park or stage Pedicab at any metered or pay station parking space, or at any location where it is prohibited for a passenger motor vehicle to park (i.e., red, blue, yellow, green and white curbs and zones as posted).
53. Must not park or stage at Commercial Yellow and White Zones. These Zones are dedicated to Commercial Vehicles, buses and shuttles for active loading and unloading only.
54. Racing of any kind is absolutely prohibited while operating a Pedicab.
55. Must not operate a pedicab after dark without a functioning headlight, taillight and reflectors as defined in 33.4618 of the San Diego Municipal Code.
56. Must not operate a Pedicab on any road or street with a speed limit greater than 25 miles per hour as per the California Vehicle Code, unless an adjacent bike lane exists within the road or street.
57. Pedicabs must be operated in compliance with the California Vehicle Code.
58. Pedicab Operator must always keep the City of San Diego Business Tax Certificate on them while operating a Pedicab.
59. Pedicabs must only operate with static single-color lights. No flashing, racing, or changing color lights allowed at any time the Pedicab is operated on District tidelands.
60. Must submit Pedicab to an inspection by Harbor Police or designated authority upon request.
