

EXHIBIT A

PEDICAB CODE OF CONDUCT

The following Pedicab Code of Conduct must always be obeyed by all Pedicab Operators and any Drivers (as those terms are defined in the Pedicab Operating Agreement) while operating a Pedicab on or in any property within the District's jurisdiction:

1. No person shall operate a Pedicab, nor permit another person to operate a Pedicab owned or controlled by them, without having entered into a valid Pedicab Operating Agreement with the District.
2. No person shall operate, nor permit another person to operate, a Pedicab they own or control without having consented in writing to the terms of this Code of Conduct.
3. No person shall permit another person to operate a Pedicab that they own or control unless and until that other person has also consented in writing to the terms of this Code of Conduct.
4. No person shall operate a Pedicab without displaying the valid Pedicab Placards/Decals issued by the District. Placards/Decals shall not be covered or removed from the locations to which they are affixed.
5. Pedicabs shall display City of San Diego Operator's Permit, company name, and company phone number clearly, on the outside and inside of the Pedicab at all times.
6. Motorized Pedicabs shall not ride, stage, or otherwise operate on any sidewalk, promenade, multi-use pathway, nature trail, plaza, public parking garage, pier or park, and shall operate the same as motor vehicles in driveways and on streets.
7. Pedal-Only Pedicabs shall not ride, stage, or otherwise operate on any sidewalk, promenade, multi-use pathway, nature trail, plaza, public parking garage, pier, or park, unless specifically designated as a "Pedal-Only" allowed route as defined in the Operating Agreement Maps, **Exhibit B**, attached herein. Pedal-Only Pedicabs may operate on roadways, streets, and driveways where Motorized Pedicabs are allowed to operate.
8. No person under the age of twenty-one (21) years old shall operate a Pedicab.
9. No person shall operate a Pedicab in an unsafe manner.
10. No person shall operate a Pedicab in such a manner as endanger pedestrians, other drivers and passengers, or the public at large.
11. No person shall operate a Pedicab at a speed that is unsafe for current roadway conditions.
12. Persons operating Pedicabs shall act to ensure the safety of Pedicab passengers and the general public and shall take all necessary measures to avoid collisions or incidents.
13. No person shall operate a Pedicab in such a manner as to impede the free flow of traffic, including pedestrian traffic.
14. No person shall drive a Pedicab onto, stage a Pedicab on, or operate a Pedicab on any pier on District tidelands, including but not limited to, B Street Pier, Broadway Pier, Navy Pier, or Imperial Beach Pier.
15. Persons operating Pedicabs shall obey all traffic signals, signs, and posted speed limits.
16. Persons operating Pedicabs shall come to a full stop at all stop signs.
17. Persons operating Pedicabs shall come to a complete stop and remain stopped at all red traffic signals.

18. Persons operating Pedicabs shall not make U-turns, except at intersections that allow U-turns.
19. A person operating a Pedicab shall drive such Pedicab as close as practical to the right edge of the road unless preparing to turn left.
20. Persons operating Pedicabs shall always drive the Pedicab in the same direction as vehicles are required to be driven on the roadways, streets, and in parking lots and driveways.
21. Persons operating Pedicabs shall not drive a Pedicab the wrong way on a one-way street or driveway.
22. Persons operating Pedicabs shall not pass a motor vehicle or Pedicab left of a double yellow line.
23. Persons operating Pedicabs shall make all right turns from the far-right hand edge of the road.
24. Persons operating Pedicabs shall make all left turns from the far-left lane open to vehicles traveling in Pedicab's direction.
25. Persons operating Pedicabs shall not drive a Pedicab over, on, or in a painted center island, as designated by double-parallel yellow lines.
26. Persons operating Pedicabs shall keep to the right except to pass.
27. Persons operating Pedicabs shall always give pedestrians the right of way.
28. Persons operating Pedicabs shall use hand or mechanical signals when turning or changing lanes.
29. Persons operating Pedicabs shall not block crosswalks, promenades, or ingress or egress to any property.
30. Persons operating Pedicabs shall not impede traffic, including but not limited to that of buses, shuttles, other vehicles, and pedestrians.
31. Persons operating Pedicabs shall not grab onto, or attach a Pedicab to, a moving vehicle.
32. Persons operating Pedicabs shall not operate a Pedicab in an unsafe manner, including but not limited to "swerving."
33. Persons operating Pedicabs shall not operate any amplified sound devices and must not amplify any sound or music which can be audible outside of the pedicab while operating on District property.
34. Persons operating Pedicabs shall immediately report all accidents and injury collisions involving a Pedicab on District property to **Harbor Police at 619-686-6272**.
35. Persons operating Pedicabs shall provide the Pedicab company's insurance information upon demand by any party involved in a collision or incident with a Pedicab.
36. Persons operating Pedicabs shall not permit anyone other than an authorized employee, contractor, subcontractor, or agent to drive the Pedicab.
37. Pedicabs shall only be operated by one person, and the total number of passengers shall be limited by the total number of seatbelts provided in the Pedicab seating area.
38. Persons operating Pedicabs must ensure that all passengers wear a seatbelt at all times while inside the Pedicab.

39. Persons operating Pedicabs shall not permit a child incapable of safely wearing a seatbelt to ride in a Pedicab unless (1) a child restraint system compliant with State law (including but not limited to California Vehicle Code section 27360, et seq.) is used; and (2) the child restraint system is capable of safely being installed into the Pedicab.
40. Persons operating Pedicabs shall not overload a Pedicab.
41. Persons operating Pedicabs shall ensure that each passenger occupies an unused seat in the Pedicab and shall not permit passengers to share seats or to sit in the lap of another passenger or the driver.
42. No person shall operate a Pedicab while carrying any package, bag, or bundle that prevents the use of at least one hand to steer the Pedicab.
43. Persons operating Pedicabs shall not leave the Pedicab unattended in the Pedicab Parking Zones.
44. Persons operating Pedicabs shall not sit in the passenger seating area while waiting for passengers.
45. Persons operating Pedicabs must use Pedicab Parking Zones only as designated and shall not park outside of Pedicab Parking Zones.
46. Persons operating Pedicabs shall not smoke or use a mobile phone while operating a pedicab.
47. Persons operating Pedicabs shall be courteous and not aggressive when soliciting for passengers.
48. Persons operating Pedicabs shall post a per person fare schedule clearly visible to all passengers outside and inside of the Pedicab.
49. Persons operating Pedicabs must verbally agree with passengers to a total per person fare prior to commencing a ride.
50. Persons operating Pedicabs shall not demand or accept a fare greater than the fare posted on the fare schedule.
51. Persons operating Pedicabs shall not operate a Pedicab under the influence of any substance capable of impairing a person's ability to safely operate a vehicle, including but not limited to alcohol and controlled substances.
52. Persons operating Pedicabs shall ensure all luggage or personal items are properly secured within the Pedicab.
53. Persons operating Pedicabs shall complete Pedicab safety checks each time they take out a Pedicab, including seatbelts, lights, and brakes, etc.
54. Persons operating Pedicabs shall not operate a Pedicab within the perimeter of a special event area, except at a designated drop off or pick up zone as may be designated by the District.
55. Persons operating Pedicabs shall not operate within any construction zone and must obey all posted construction zone signs and marked detours.
56. Persons operating Pedicabs shall not park or stage a Pedicab at any metered or pay station parking space, or at any location where it is prohibited for a passenger motor vehicle to park (i.e. red, blue, yellow, green, and white curbs and zones as posted).
57. Persons operating Pedicabs shall not park or stage at Commercial Yellow and White Zones. These Zones are dedicated to Commercial Vehicles, buses, and shuttles for active loading and unloading only.
